Reporting Protocols against which assurance was conducted:

 The Subject Matter needs to be read and understood together with the GRI Standards, the Sustainability Accounting Standards Board (SASB) Standards, and Ansys' internal reporting protocols.

Level of Assurance and Qualifications:

- Limited
- Excluded from the scope of our work is any assurance of information relating to:
 - Activities outside the defined assurance period.
- This assurance used a materiality threshold of ±5% for aggregate errors in sampled data for each of the above indicators
- This limited assurance engagement relies on a risk based selected sample of sustainability data and the
 associated limitations that this entails. The reliability of the reported data is dependent on the accuracy of
 measurement arrangements employed and are not addressed as part of this assurance. This independent
 assurance statement should not be relied upon to detect all errors, omissions or misstatements that may
 exist.

Assurance Methodology:

Evidence-gathering procedures included but were not limited to:

- Interviews with relevant personnel of Ansys;
- Review of documentary evidence produced by Ansys;
- Review of Ansys data and information systems and methodology for collection, aggregation, analysis and review of information used to determine social metrics data; and,
- Audit of sample of data used by Ansys to determine social metrics data.

Assurance Opinion:

Based on the process and procedures conducted, there is no evidence that the social metrics data assertion shown above:

is not materially correct and is not a fair representation of the social metrics data and information.

It is our opinion that Ansys has established appropriate systems for the collection, aggregation and analysis of quantitative data for determination of these social metrics data for the stated period and boundaries.
